## **Biography**

Andrew spent decades preparing for his role as an associate attorney at Kightlinger & Gray. He enlisted in the United States Army after high school to earn money for college and served on active duty as a Signals Warfare Intelligence Analyst for three years. During this time, Andrew maintained a top-secret security clearance. He was also awarded the Global War on Terrorism Expeditionary Medal after he completed a six-month deployment to the Middle East in 2003. Andrew earned a Legal Studies degree from Ball State University in 2008.
